PARKING IS PROVIDED AS A CONVENIENCE AND PRIVILEGE. SCHOOL OFFICIALS RETAIN THE RIGHT TO EXAMINE THE CONTENTS AND/OR SEARCH A CAR PARKED ON SCHOOL PREMISES WHEN THEY HAVE A REASONABLE SUSPICION THAT ITEMS CONTAINED IN THE CAR MAY INTERFERE WITH THE SAFE OR EFFECTIVE OPERATION OF THE SCHOOL.

PARKING PRIVILEGES CAN BE TAKEN AWAY AT ANY TIME AND/OR DISCIPLINARY ACTION TAKEN FOR THE FOLLOWING REASONS TO INCLUDE BUT ARE NOT LIMITED TO:

- A. TARDINESS TO SCHOOL (LOSS OF PARKING AS EXPLAINED IN TARDY POLICY)/POOR ATTENDANCE
- B. POOR DRIVING HABITS
 - 1. RECKLESS OPERATION OF YOUR VEHICLE
 - 2. NOT FOLLOWING THE ASSIGNED TRAFFIC PATTERN
 - 3. DRIVING IN AN OFF-LIMITS AREA
 - 4. RUDE OR VULGAR BEHAVIOR WHILE DRIVING ON CAMPUS
- C. UNSAFE VEHICLE
- D. PARKING TAG NOT PROPERLY DISPLAYED
- E. NOT PARKING IN YOUR ASSIGNED PARKING SPACE.
- F. PARKING IN THE STAFF LOT.
- G. STUDENTS ARE NOT ALLOWED TO TRADE/SWITCH PARKING SPACES WITHOUT PRIOR PERMISSION FROM THE ADMINISTRATION**
- H. STUDENTS ARE NOT ALLOWED TO DRIVE THROUGH THE BUS PICK-UP/DROP-OFF AREA

THE SCHOOL IS NOT RESPONSIBLE FOR THE VEHICLE OR ITS CONTENTS. STUDENTS APPLYING FOR THE PARKING PERMIT ACCEPT FULL RESPONSIBILITY FOR KNOWING AND FOLLOWING THE ABOVE REGULATIONS. AFTER PARKING, STUDENTS ARE EXPECTED TO COME DIRECTLY TO THE BUILDING AND NOT SIT IN HIS/HER CAR.

THE PARENT'S SIGNATURE ON THIS APPLICATION SHOWS THEIR APPROVAL FOR THIS STUDENT TO DRIVE TO SCHOOL. THE COST PER PARKING PERMIT IS \$50.00 PER YEAR. PERMIT IS TO BE PLACED ON THE FRONT WINDOW OR ON THE INSIDE MIRROR.
